DIRECTIONS TO OUR BELLEVUE OFFICE

Coming Northbound on I-405

Take the NE 4th Exit, Eastbound

At the top of the off ramp, there is a light.

At that first light, take a right turn which will have you going to 116th NE

Take a left to go northbound on 116th NE.

Continue northbound past Overlake Hospital.

When you see NE 19th Avenue, turn left into 19th

Take a left on 115th and proceed to the end of the cul-de-sac

We are in a yellow colored, remodeled home with parking in front and back. Client parking is in front of the office.

Coming Southbound on I-405

Take the Seattle exit to SR-520.

Take the very first exit once you are on SR-520

Go to the bottom of the off-ramp, and take a right turn at the light.

Take another right turn at the next light, and proceed easterly on Northup.

Take a right turn on 116th Avenue NE

Proceed southbound on 116th until you see NE 19th

Turn right on to 19th

Take a left on 115th and proceed to the end of the cul-de-sac

Coming to Bellevue from Eastbound or Westbound I-90

Take Northbound I-405 (Everett exit) and then follow the 405 directions above.

Coming to Bellevue via SR-520 Eastbound from Seattle

Going westbound on SR 520, take the Kirkland Exit and cross over SR-520 overpass

At light turn on to Northup Way (You will see Newport Beach Restaurant)

Proceed easterly on Northup.

Take a right turn on 116th Avenue NE

Proceed southbound on 116th until you see NE 19th

Turn right on to 19th

Take a left on 115th and proceed to the end of the cul-de-sac

Coming to Bellevue via SR-520 Westbound

Take the very first exit once you cross under I-405 overpasses and are past the I-405 on-ramps (Everett/Bellevue).

Go to the bottom of the off-ramp, and take a right turn at the light.

Take another right turn at the next light, and proceed easterly on Northup.

Take a right turn on 116th Avenue NE

Proceed southbound on 116th until you see NE 19th

Turn right on to 19th

Take a left on 115th and proceed to the end of the cul-de-sac
